



Local Action Plans for Education Development II (LAP II)

(Call No 02_17_047)

What is the aim of this call?

The aim of the call is to promote joint planning and sharing of activities in the territory. The call supports interventions planned in the Local Action Plan, which improve the quality of education in nursery and primary schools by encouraging cooperation among education authorities, schools and other stakeholders in education including non-formal education organizations. This cooperation will focus on joint information, education and planning of partnership activities for subsequent joint solutions to local-specific problems and needs, and evaluation of the cooperation benefits.

Who can apply for a grant?

- Eligible applicants must belong to one of the following categories and also meet all the conditions set out in chapter 5.2.1 of the Rules for Applicants and Beneficiaries – specific part.
- Local Action Groups: private entities carrying on an activity in the public interest (private non-profit organisations – association, institution, public benefit society) listed in the database of Local Action Groups
- Municipalities
- Voluntary inter-municipal cooperatives: an inter-municipal cooperative entered in the register of inter-municipal cooperatives maintained in accordance with Act No 128/2000 Coll., on municipalities (Municipal Establishment), as amended
- An association/ alliance of municipalities (micro-region, or a league of municipalities and micro-regions) entered in the public register with the legal form of an association of legal persons or an alliance
- Municipal districts of the City of Prague

What is the amount of financial support?

- Allocation for the call: CZK 3 000 000 000
- Minimum amount of expenditure: CZK 3 000 000
- The maximum amount of expenditure is determined by the following formula:
$$\text{CZK } 8\,000\,000 + (\text{number of participating schools (based on Organisation Identifier IZO } ^1)) \text{ in municipalities with extended powers} \times \text{CZK } 100\,000$$

¹ the Organisation Identifier is an identifier of primary and secondary schools in the Czech Republic

What activities are eligible?

Mandatory activities:

- Project management
- Development and update of LAPs
- Evaluation and monitoring of LAPs
- Implementation of LAPs

How and when to apply?

Grant applications are submitted through IS KP14+ (<https://mseu.mssf.cz>) in the period from 15.11.2017, 14:00 until the allocation is exhausted or until the decision of the Managing Authority, but no later than 04.01.2019, 14:00.

Interim closing dates for receiving grant applications are: 14.12.2017 till 14:00, 15.02.2018 till 14:00, 15.05.2018 till 14:00, 22.06.2018 till 14:00, 14.09.2018 till 14:00, 31.10.2018 till 14:00, 04.01.2019 till 14:00.
