## **Executive summary**

Evaluation<sup>1</sup> of the coverage of Priority Axis 1 by Operational Programme Research, Development and Education (OP RDE) calls was made by a functionally independent Evaluation Unit of the OP RDE for internal needs of the OP Managing Authority.

This analysis aims to identify activities listed in the OP RDE programme document which have not yet been covered by any announced/opened call and furthermore to determinate the coverage intensity of activities already covered by closed or ongoing calls.

In order to carry out this evaluation the method of desk research of primary sources (individual calls of the Priority axis including their Rules for Applicants and Beneficiaries - specific part) was used, as well as the OP RDE programme document itself.

Up to now, **twelve calls for proposals with total budget of CZK 28,498,000,000** have been opened under Priority Axis 1 in total. Of these, eleven calls have already been closed. Within Priority Axis 1, one call is currently ongoing, namely 02\_17\_043 Teaming II.

The analysis shows that most of the calls have so far been opened in specific objective 1 (SO 1), five calls in total, but this corresponds to the scope of this specific objective and to the greater extent of the activities mentioned in the program document OP RDE under this specific objective. The fewest calls have been announced so far in a specific objective 4, only one call. This specific objective appears to be the least covered so far in the range of activities mentioned for SO4 in the OP RDE programme document.
