

Executive summary

Evaluation of the coverage of Priority Axis 2 (PA 2) by Operational Programme Research, Development and Education (OP RDE) calls was made by a functionally independent Evaluation Unit of the Operational Program Research, Development and Education for internal needs of the OP Managing Authority.

This analysis aims to identify activities listed in the OP RDE which have not yet been covered by any announced/opened call and furthermore to determinate the coverage intensity of activities already covered by closed or ongoing calls.

In order to carry out this evaluation the method of desk research of primary sources (individual calls of the priority axis including their Rules for Applicants and Beneficiaries - specific part) was used, as well as the OP RDE programme document itself.

Up to now, within the priority axis 2 fourteen calls were announced/opened with total budget of **23 975 000 000 CZK**. Of these, twelve calls have already been closed. Within Priority Axis 2, two calls are currently ongoing, namely 02_18_055 Smart Accelerator and 02_16_031 Lifelong learning at universities.

The analysis shows that most of the calls have so far been opened in investment priority 1 (IP1) specific objective 5 (SO5), eight calls in total with the budget of CZK 5,110,000, 000, but this corresponds to the scope of this specific objective and to the greater extent of the activities mentioned in the programme document OP RDE under this specific objective. However, only within this specific objective are two activities listed in the programme document OP RDE that are covered only partially. The other specific objectives and their activities listed in the programme document OP RDE are fully covered by OP RDE calls. The fewest calls have been announced so far in a specific objective 3, but the only one activity listed under this specific objective in the programme document OP RDE is covered.

Within the IP 2 PA2 SO1 up to now three calls have been opened for CZK 14,665,000,000 and all activities listed in programme document OP RDE are covered.

- Improving the quality of university instruction
- Making higher education more relevant to the needs of the labour market
- Creation or upgrading of research-oriented study programmes with an emphasis on problem-oriented research

- Development of international co-operation and international environment at universities
- Strengthening of the intersectoral mobility of researchers (from the private sector to public research) and international mobility of researchers**

- Staffing of internal grant support for research organisations
- Support of balanced professional development of research men and women according to the approach of cultural and institutional changes for promoting of gender equality
- Support of human resources in RD can include also organization of national and international scientific conferences, seminars, etc.
- Activities focused on better information availability of offered study programs and university studies for interested students in order to reduce their future study failure
- Activities that shall influence students and future students with Sen and from socio-economically disadvantages groups and ethnic minorities (mainly Roma people) in order to increase their number in universities
- Improving the qualifications of staff involved in the preparation and implementation of LL courses, and support of the acquisition and creation of relevant tools

- Adaptation of premises and purchase of necessary equipment to accommodate students with special needs
- Development and modernisation of classrooms and laboratories
- Development of premises intended for practical training at universities
- Reconstruction and restoration of unsuitable buildings intended for university education to improve the quality of the provided educational activities
- Acquisition of new information sources/development of the existing information sources and management systems, upgrade of software equipment and acquisition of new internal information sources/development of the existing internal information sources
