Executive summary

Factual progress regarding the phase of implementation of the programme on the reference date partially corresponds to the expected OP RDE implementation.

The fulfilment of the real values of the result indicators and output indicators given by the programming document was as of 16 July 2018 zero for more than half. Only 69 of 156 result and output indicators across priority axes to which projects are directly committed have a non-zero value. Furthermore there are 6 indicators which have not been covered by the calls yet.



The risk of not-fulfilling target values and the risk of overfulfilling target values has been identified.

A risk of non-fulfilment is identified by 41 out of 156 programme indicators. The list of given indicators is given in the following table:

PA1: The factual indicators in PA1 have a zero value as of 16 July, 2018. From the point of view of meeting the values for the indicators for the 31 December 2018 milestone, there is a risk of their nonfulfillment, not only the required 85% of the threshold but also the 65% of the threshold of the 2018 milestone, which would mean a serious failure of the OP RDE. The total value of commitments at the end of the programme period, together with the target values of the calls, indicates the risk of overfulfillment of the indicator. However, based on the MEYS's own research and addressing the beneficiaries, it is estimated that all PA1 indicators will be met to more than 100% of the milestones as of 31 December 2018. In PA1, 2 milestone indicators (1 factual and 1 financial) are defined for LDR and MDR. Each indicator has to reach at least 85% of its milestone.

PA2: Due to the relatively low total value of the commitments with the projected end date of the projects as on 31 December 2018, there is a risk of non-fulfillment of the 2018 value for all factual indicators (MDR and LDR) apart from the indicator Acquired information sources (LDR). Based on the results of the questionnaire survey, it can be estimated that the given risk is partly mitigated and it is estimated that in the factual indicators - Acquired information sources (LDR and MDR) and The number of students using newly created, expanded or modernised infrastructure apart from infrastructure connected with research (MDR) will not reach at least 85% of the value of the milestone. However, the Total Number of Participants (MDR and LDR) and Number of students using newly developed, expanded or modernised infrastructure apart from infrastructure connected with research do not reach 75% of the value as of 31 December 2018. Conversely, there is a risk of over-fulfillment for all LDR indicators (Total number of participants, Acquired information sources, The number of students using newly created, expanded or modernised infrastructure apart from infrastructure connected with research) at the end of the programme period. In PA2, milestones are defined for each fund (ESF and ERDF) and each category of regions (MDR and LDR). A total of 5 milestones (3 factual and 2 financial,

in particular for ERDF part of PA2 there are 2 factual and 1 financial indicator and for ESF part of PA2 there is 1 factual and 1 financial indicator). In order to meet the milestone, it is necessary that for 2 milestone indicators (ie ESF part of PA2), 2 indicators of each fund have reached at least 85%, and for each of the 3 milestone indicators (ie ERDF part of PA2), 2 indicators have reached at least 85% and 1 indicator at least 75% of its milestone value. If the two indicators of each fund do not reach at least 65% of their milestone value, it will be taken as serious failure of the OP RDE.¹

PA3: All indicators have achieved values as of 16 July 2018. For the indicator Total number of participants (MDR), the risk of non-fulfilment of the value of the milestone is identified as 85%. However, on the basis of its own investigation, the Ministry of Education estimated it to be fulfilled at the 99% of the milestone as of 31 December 2018.



Financial progress is lower than expectations stated in the OP RDE programme document

On 30 June 2017, a total amount of 58,871 m CZK was committed, representing 65.8% of the allocation. The share of the funds paid to the total allocation is then 27% and is not the same as the time progress of the programme implementation (currently half of the fourth year of implementation). At the same time, the share of funds paid to committed means is relatively low, especially in PA2. The financial volume of the announced calls accounts for almost 83% of the OP allocation (67% of the ESF allocation and 94.3% of the ERDF allocation). A detailed overview is shown in the following table.

In PA1, fulfilment of financial indicator of the milestone with sufficient margin can be predicted only in LDR already when RfP predicted in the 3rd Q 2018 are included. In MDR, sufficient margin can be predicted only if payments from 4th quarter 2018 are included.

¹ On 13 August 2018, the EC decision was issued for the amendment to OP RDE (date of entry into force of the amending decision of the Member State on 3 May 2018), which establishes a new factual indicator in PA2 - Number of supported products. This will increase the number of indicators to a total of 6 (2 factual and 1 financial for each fund). Therefore, it will be the case that in order to achieve the milestone for each fund it is necessary that the 2 indicators reach at least 85% and one indicator of at least 75% of their value. If the two indicators did not reach at least 65% of their value, this would be a serious failure to fulfill the OP RDE performance framework."







In PA2, reaching of at least 85% of value of financial indicators of the milestone can be predicted only in ESF and MDR that is the limit value. In the other two cases (ERDF in LDR and ESF in MDR), 85% of financial indicators of milestones are not achieved even if payments are included in Q4. The essential prerequisite for achieving at least 85% of the ERDF level is an intensive and effective spending of resources over the 3rd Q 2018 for higher education projects under the call 02_16_016 ERDF Call for universities. Another call which should contribute to at least 85% of the value is Call 02_17_044 Support of the development of the study environment at universities. Allocation in Call 02_17_044 has been increased and legal acts have been concluded in the first half of 2018. In addition, the conditions in this call were set to create sufficient assumptions for the expected fulfillment of the limit in 2018.

In PA3, fulfilment of financial indicator of the milestone with sufficient margin can be predicted already when considering only predicted requests for payments for 3rd quarter 2018. In the case of MDR, achievement of 100% is the limit.

Financial indicators (PA1, PA2, and so on) with a defined milestone value represent milestone indicators whose performance rate affects the performance of the milestone of the respective PA.



The operational programme's ability to meet the N+3 rule is currently threatened.

Prediction of absorption of funds based on requests for payments in projects that were being implemented on 30 June 2018 or were supposed to have a legal act issued by the end of 2018 is CZK 13 776 million. This means that the absorption degree of the main allocation for year 2015 is 74.8% of the allocation.

Based on the current status of the financial progress on 30 June 2017, no risk of non-utilization of allocated resources of the OP RDE has been identified.

All specific objectives of OP RDE are covered by at least one announced or closed call or by at least one call in the Schedule of Calls. The absorption capacity of the calls was in the case of all the calls completed in the period from 1 January to 2018 to 30 June 2018 estimated correctly. The analysis showed that mostly high-quality (based on the number of points) project applications were supported, only in the call 02_17_044 Support of the development of the study environment at universities medium-quality applications prevailed.



Factors that can seriously prevent the effective implementation of OP RDE from being carried out have been identified.

The identified factors that currently have a negative effect on the progress of implementation of the programme are mentioned in the table below. The factors are divided into serious (red), moderate (orange) and minor (green).

	Based on the analysis of the indicators, the risk of non-fulfillment of 85% of the value of milestones was identified by factual indicators. The risk is partially mitigated on the basis of estimates by recipients addressed in the questionnaire survey and by the Ministry of Education, Youth and Sports, who are planning to report the indicators so much that the 85% milestone is reached. Thus, the risk indicators remain only the indicators of PA2 Total number of participants (LDR and MDR) and Number of students using newly built, expanded or modernised infrastructure apart from infrastructure connected with research where there's a risk of non-fulfilling 85% of the milestone after additional investigations. The occurrence of the risk depends on the ability of the beneficiaries to report the values of the indicators in the RfPs according to their assumptions stated in the questionnaire.	
The extent of the fulfilment of the financial indicators of the 2018 milestone in PA2 is insufficient	The risk is presented in the Summary Report on Risk Management in OP RDE, No. 10/76 Non-fulfillment of financial indicators of milestones. The expected value of meeting the financial milestones can be considered overall insufficient, even after the revision of the performance framework. Having taken into account payments up to the 3rd Q 2018, it is not possible to expect to reach 85% for any of the financial indicators of the milestone. Having taken into account the payments in the 4th Q 2018, the 85% threshold should be reached with a sufficient margin only for ESF and LDR, and for other financial indicators, the other financial indicators can be expected to be in the range of 80.8% to 87%.
