



Inclusive education for socially excluded localities II (SEL II)

(Call No 02_19_075)

What is the aim of this call?

To improve the quality of education of children and pupils in the territory of socially excluded localities (SEL). Support for municipalities and Regions, whose territories include a SEL, in their role of inclusive education coordinators. Securing funding for nursery, primary and secondary schools and non-formal education establishments for the introduction and implementation of individual integration. Organizing awareness-raising activities for the public, support for establishing new platforms, implementation of workshops for various stakeholders in education and the opportunity of study visits in EU countries.

Who can apply for a grant?

Eligible applicants must belong to one of the following categories and also must meet all the conditions set out in chapter 5.2.1 of the Rules for Applicants and Beneficiaries – specific part. A complete list of eligible applicants and partners is in the text of the call (sec. 4.1 and 4.2).

Category I

- Municipalities
- An association of municipalities entered in the public register with the legal form of an association of legal persons or an alliance
- Inter-municipal cooperative entered in the register of inter-municipal cooperatives
- Municipal districts of the City of Prague

Category II

- Higher territorial self-governing units - Regions (including the City of Prague)

Category III

- Private-law entities whose main purpose is not to generate profit
- Associations of legal entities

What is the amount of financial support?

- Allocation of the call: CZK 700 000 000
- Minimum amount of expenditure: CZK 3 000 000
- Maximum amount of expenditure: CZK 100 000 000

What activities are eligible?

All projects must include both the mandatory activities and some mandatory-to-select activities. Details of the below-mentioned activities are provided in chapter 5.2.4 of the Rules for Applicants and Beneficiaries – specific part.

Mandatory activities

- Project management (mandatory activity for all categories of applicants)
- Support for municipalities/ Regions in introducing inclusive education (mandatory activity only for applicants in category I and II)

Mandatory-to-select activities

- Preschool education
- Preventing school failure
- Personnel support of inclusive education in schools and educational counselling facilities

What target groups can be supported?

Mandatory target groups:

- Pupils/ children from socio-economically disadvantaged and culturally different background
- Parents and persons to whom the child/ pupil is entrusted in custody

Other eligible target groups

- Pupils who are at risk of dropout
- Children and pupils, if the project activities are aimed at creating an inclusive environment in schools and other non-formal education establishments
- Staff of schools and education establishments, management of schools and education establishments
- Staff and volunteers working in the area of education or assistance services and in non-formal education, students of teacher training faculties and courses focused on education
- Staff of public administration and of education authorities sponsoring schools and educational establishments.

Grant applications are submitted through IS KP14+ (<https://mseu.mssf.cz>) in the period from 21.01.2019 until the allocation is exhausted, at the latest till 30.06.2020, 14:00.
