What is the aim of this call?

Call Research Infrastructures II focuses on investment activities of large research infrastructures, in the case of call Research e-infrastructures this means specifically the investment activities of large research e-infrastructures. The aim of the call is to support the modernization and upgrade of large research infrastructures and e-infrastructures, complementarily funded from targeted support for large research infrastructures, provided by the Ministry of Education, Youth and Sports in the period up to 2022.

Who can apply for a grant?

The entities that meet the definition of an organization for research and dissemination of knowledge in accordance with the Framework, while working as a research infrastructure and being host or partner institutions of a large research infrastructure (e.g. public higher education institutions, research institutions, private entities carrying on an activity in the public interest) and having a non-zero financial requirements on capital expenditure.

All conditions are detailed in the call and Chapter 5.2.1 of the Rules for Applicants and Beneficiaries - specific part.

What is the amount of financial support?

Research Infrastructures II

- Allocation of the call: CZK 1 900 000 000
- The minimum amount of expenditure is not specified
- The maximum amount of expenditure per project is set in the call

Research e-infrastructures

- Allocation of the call: CZK 1 100 000 000
- The minimum amount of expenditure is not specified
- The maximum amount of expenditure per project: CZK 1 100 000 000

What activities are eligible?

Mandatory activities:

- Project management
- Modernization or upgrading of a large research infrastructure in the Czech Republic - In this activity, it is possible to acquire modern instrumentation and technical equipment, as well as carry out building modifications required to install new apparatuses (e.g. adjusting the wiring, floors) and possibly building modifications leading to a change in the intended use of the space within the facility in accordance with the activities supported in the call.

Optional Activity:

- In-kind contribution - a supply of parts to research infrastructures located in other EU countries.

What target groups can be supported?

Mandatory target groups:

- Pupils/ children from socio-economically disadvantaged and culturally different background
- Parents and persons to whom the child/ pupil is entrusted in custody

Other eligible target groups

- Pupils who are at risk of dropout
- Children and pupils, if the project activities are aimed at creating an inclusive environment in schools and other non-formal education establishments
- Staff of schools and education establishments, management of schools and education establishments
- Staff and volunteers working in the area of education or assistance services and in non-formal education, students of teacher training faculties and courses focused on education
- Staff of public administration and of education authorities sponsoring schools and educational establishments.

The calls were announced on 18.12.2018. Grant applications will be received through IS KP14+ (mseu.mssf.cz) in the period from 18.12.2018, 10:00 till 31.05.2019, 14:00.
