The difference between calls Templates for secondary and post-secondary vocational schools I, and Templates for secondary and post-secondary vocational schools II

- Expanded number of eligible applicants: newly also for school boarding facilities boarding houses and dormitories
- Reduced minimum total expenditures from CZK 200 000 to CZK 100 000
- Increased amounts for the calculation of the maximum amount of financial support for secondary and post-secondary vocational schools which draft the School Action Plans (SAPs)
- Modified existing templates and newly included templates (e.g. creation or editing of school education programmes (SEPs)/ SAPs, implementation of fictitious companies within teaching activities, activities developing ICT in schools, the club as a leisure activity for pupils, support for teachers through supervision/ mentoring/ coaching, project days, etc.)

Objectives of the call Templates for Secondary and Post-Secondary Vocational Schools II

- Support of personal and professional development of teachers (further education, study visits, experience sharing among teachers and practitioners, etc.)
- Help for schools and school care and boarding facilities in inclusive education through personnel support and further education in the field of inclusion
- . Help to pupils at risk of school failure
- Introduction and support for new methods in teaching
- Deeper linking of theory with practice cooperation between schools and employers

Who can apply for a grant?

- Secondary schools, conservatories and post-secondary vocational schools that have, in the school year in which they submit their grant application, at least one pupil/ student and that create their own Plans of Activities (PA) or School Action Plans (SAP)
- School care and boarding facilities school boarding houses and dormitories that
 have in the school year, in which they submit their grant application, at least one
 child/pupil/student

Entities may be from the whole country, including the City of Prague - the call will be announced for both less developed regions (LDR) and more developed regions (MDR).

What activities are supported?

- Templates for personnel support (school assistant, special pedagogue, psychologist, social pedagogue, career counsellor, coordinator of cooperation between the school and employers)
- Further training of teachers (FTT)
- Exchange of experience among teachers, tandem teaching
- Involving specialists from practice in teaching
- · Project-based teaching
- Interest clubs
- Developing literacy and numeracy
- · Activities focused on teaching with digital technologies, including their acquisition
- And other...

What is the amount of financial support?

- Allocation of the call: CZK 1 bil.
 - Less developed regions: CZK 830 000 000
 - More developed regions: CZK 170 000 000
- . Minimum amount of expenditure: CZK 100 000
- · Maximum amount of expenditure:
 - For secondary and post-secondary vocational schools
 variant A) with the approval of the Plan of Activities (PA) issued after 01.01.2019:
 CZK 200 000 per entity + (the number of full-time pupils/ students at the school
 x CZK 2 000, and/or the number of pupils/students of the school in other forms of
 - variant B) with the approval of the School Action Plan (SAP) issued after 01.01.2019: CZK 300 000 per school + (the number of full-time pupils/ students at the school x CZK 3 000, and/or the number of pupils/students of the school in other forms of study x CZK 750);
- for school care and boarding facilities school boarding houses, dormitories: CZK 100 000 per entity + (the number of children/ pupils x CZK 1 800).
- The maximum amount per applicant may not exceed CZK 5 000 000.
- The beneficiary's co-financing rate: 0%

Grant applications are submitted through IS KP14+ (https://mseu.mssf.cz) in the period from 12.12.2018 until the allocation is exhausted, at the latest till 29.11.2019, 14:00.
