



## Post-secondary vocational schools (Call No 02\_16\_041)

### What is the aim of this call?

The aim is to promote innovation in post-secondary vocational education (PSVE) by improving the quality and effectiveness of education and vocational training with an emphasis on increasing their relevance for the long-term needs of graduates, the labour market and society. The conceptual projects will be focused on a specific field of education (economic, humanities, technical, medical or educational), chosen on the basis of the accredited training programs of the PSVE school. The PSVE innovation will take place through:

- raising the level of teaching professional foreign languages
- improving the quality of vocational training,
- modernization of student assessment methods
- innovation of professional experience,
- development of further education,
- analysis of the role of PSVE and a proposal of the PSVE concept in the educational system of the Czech Republic

### Who can apply for a grant?

- Post-secondary vocational schools

### How and when to apply?

Grant applications are submitted through IS KP14+ (<https://mseu.mssf.cz>):

- In the period from 04.04.2017 till 31.8.2017, 14:00.

### What is the amount of financial support?

- Allocation for the call: CZK 250 000 000
- Minimum project size: CZK 10 000 000
- Maximum project size: CZK 50 000 000

### What are the expected outcomes of the activities?

- a knowledge standard of the graduates in professional foreign language for the given field of education,
- a knowledge standard of the graduates for the selected fields of education and their groups of disciplines,
- design of new methods of assessment and promotion of professional work/ activities of students,
- proposal for innovation of professional experience in the given field of education,
- proposal for the development of further education in the given field of education,
- analysis of the PSVE role in implementing the Educational Policy Strategy of the Czech Republic till 2020 and other strategic documents of MEYS while reflecting the position of PSVE among the fields of secondary education and professionally oriented bachelor's programmes in the given field of education,
- proposal for the vision, concept and objectives of PSVE in the given field of education.

#### Sets of open digital educational resources that cover and allow a continuous use of the set throughout the study cycle at a PSVE school:

- for teaching professional foreign language (teaching resources and methodologies of the B2 level),
- for teaching vocational subjects (teaching resources and methodologies).

#### Massive open online courses (MOOC)

- for teaching professional foreign languages,
- for vocational training,
- for teachers of vocational subjects.
