



Inclusive education for socially excluded localities (SEL)

(Call No 02_17_051)

What is the aim of this call?

To improve the quality of education of children and pupils in the territory of socially excluded localities (SEL). The call focuses not only on municipalities or inter-municipal cooperatives involved in the Coordinated Approach to Socially Excluded Localities (CASEL) but also on Regions that have SELs, not involved in CASEL, in their territory. Municipalities and Regions will be supported in the role of inclusive education coordinators in their territories, they will also be able to obtain funding for nursery, primary and secondary schools and non-formal education establishments for introducing and implementing individual integration. The call is also targeted at awareness-raising activities for the public, it supports the creation of platforms and organization of workshops for various stakeholders in education.

Who can apply for a grant?

Eligible applicants must belong to one of the following categories and also meet all the conditions set out in chapter 5.2.1 of the Rules for Applicants and Beneficiaries – specific part.

Category I

- Municipalities
- An association of municipalities entered in the public register as a special-interest association of legal entities or an alliance
- Inter-municipal cooperative entered in the register of inter-municipal cooperatives

Category II

- Higher territorial self-governing units - Regions including the City of Prague

How and when to apply?

Grant applications are submitted through IS KP14+ (<https://mseu.mssf.cz>) in the period from 22.08.2017, 10:00 until the allocation is exhausted or until the decision of the Managing Authority, but no later than 29.12.2018, 14:00.

What activities are eligible?

Mandatory activities:

Applicant of Category I

- Support for municipalities in introducing inclusive education

Applicant of Category II

- Support of Regions in introducing inclusive education

Applicants from both categories must carry out the mandatory activity “project management” and implement at least one type sub-activity from the mandatory-to-select activity - preschool education or prevention of school failure.

What is the amount of financial support?

- Allocation for the call: CZK 250 000 000
- The minimum amount of expenditure per project: CZK 3 000 000
- The maximum amount of expenditure per project: CZK 50 000 000

What target groups can be supported?

Mandatory target groups:

- Pupils or children from socio-economically disadvantaged and culturally different background
- Parents and persons to whom the child or pupil was entrusted in custody

Other eligible target groups

- Pupils who are at risk of dropout
- Children and pupils, if the project activities are aimed at the creation of an inclusive environment in a school, school facility for developing personal interests and in organizations providing leisure activities for children and youth.
- Staff of schools and education establishments, school and education establishment leaders.
- Employees and volunteers of organisations operating in the field of education or assistance services and in the field of non-formal education and leisure time for children and youth, students of teacher training faculties and of programmes focused on education of children and pupils.
- Staff of public administration and of education authorities sponsoring schools and educational establishments.
