Long-term intersectoral collaboration for ITI1 (Call No 02_17_049)

What is the aim of this call?

- intensive long-term inter-sectoral collaboration - support for establishing and developing partnerships and collaboration between research organizations and industry under jointly implemented research
- establishing and equipping a joint research centre
- supporting bidirectional transfer of unique knowledge and experience of the entities involved - linking the latest research findings with practical problems
- transfer of joint knowledge and experience towards the target groups

Who can apply for a grant?

Entities meeting the definition of a research and knowledge dissemination organisation according to the Framework for State aid for R&D&I.

Partnership

Partnership is mandatory in the call. Eligible mandatory partners may include:

- business corporations (i.e. entities pursuant to Act No 90/2012 Coll., on commercial companies and cooperatives, as amended),
- state-owned enterprises (i.e. entities pursuant to Section 2 of Act No 77/1997 Coll., on State Enterprises, as amended), which also satisfy the conditions herein.

These entities must participate in research activities of the project and will be supported in accordance with Art. 25 Commission Regulation (EU) No 651/2014.

How and when to apply?

Grant applications are submitted through IS KP14+ (<https://mseu.mssf.cz>):

- in the period from 11.07.2017, 10:00 till 15.11.2017, 14:00.

What activities are supported?

- **Mandatory activities:**
 - project management,
 - establishing, implementing or enhancing cooperation and partnership of research organizations with industry,
 - preparing and establishing long-term collaboration of research organizations with businesses,
 - cooperation in the implementation of joint research activities or projects.
- **Activities mandatory to select (the applicant must select at least one):**
 - establishing and deepening international cooperation with foreign research entities and industry entities,
 - establishing and intensifying partnerships across disciplines or sectors,
 - preparing joint international grant applications related to the activities and the project focus.
- **Optional activities (the applicant may choose any):**
 - creation or development of joint research workplaces, including the acquisition of infrastructure,
 - dissemination of results of joint research activities and their outputs,
 - professional training of researchers, related to the activities and focus of the project,
 - membership in professional organizations/ platforms/ consortia,
 - involving representatives of industry in teaching, including mentoring of student work.
