What is the aim of this call?

- The call is aimed at projects that will prepare conceptual materials to help modernize curricular documents in terms of involvement of digital technologies.
- The conceptual materials will consistently take into account the needs of inclusive education.

Who can apply for a grant?

Public higher education institutions pursuant to Act No 111/1998 Coll., on higher education institutions, that have an accredited Master's degree programme in pedagogical sciences focused on educating teachers of lower primary schools (grades 1 - 5) and at the same time a study programme aimed at preparing nursery teachers and at the same time accredited study courses leading to the vocational qualification of a teacher of upper primary school (grades 6 - 9) or a secondary school teacher (accredited in various study programmes).

How and when to apply?

Grant applications are submitted through IS KP14+ (*https://mseu.mssf.cz*): • in the period from 01.11.2016 till 01.03.2017.

What target groups can be supported?

- Teaching staff of schools and educational establishments
- HEI students future teachers
- Children in nursery schools
- Primary school pupils
- Secondary school pupils
- Academics who teach in faculties that train teachers

What activities are supported?

- Two conceptual projects will be selected. One project on the theme "Developing digital literacy of children and pupils" and one project on the theme "Developing informatics thinking of children and pupils".
- At the same time, the applicant selects the appropriate activities according to the chosen theme.
- Theme "Developing digital literacy of children and pupils" mandatory activities:
 - Cooperation with the National Institute for Education, the educational counselling facilities and establishments for further education of teachers;
 - · Capacity building for the development of digital literacy of children and pupils;
 - Popularization of digital literacy development of children and pupils.
- Theme "Developing informatics thinking of children and pupils" mandatory activities:
 - Cooperation with the National Institute for Education, the educational counselling facilities and establishments for further education of teachers;
 - Capacity building for the development of informatics thinking of children and pupils;
- Popularization of developing informatics thinking of children and pupils.

What is the amount of financial support?

- Allocation of the call: CZK 250 mil.
- The minimum amount of financial support: CZK 50 million
- The maximum amount of financial support: CZK 125 mil.
- The place of impact of the implemented projects is the whole territory of the Czech Republic
