The difference between calls Templates I and Templates II

- Expanded number of eligible applicants newly designed for basic arts schools and non-formal education establishments
- Reduced minimum total expenditures from CZK 200 000 to CZK 100 000
- Increased amounts for calculating the maximum amount of financial support for nursery and primary schools
- Newly included templates (e.g. project days, the involvement of practitioners in education, school career counsellors at primary schools, activities developing ICT in schools)

Objectives of call Templates II

- Support for inclusive education
- Personnel support (e.g. school assistants, special pedagogues, school psychologists, nannies)
- Training of teachers in inclusion

Who can apply for a grant?

Entities may be from the whole country, including the City of Prague (the call will be announced for both less developed regions and more developed regions).

What activities are eligible?

- Templates for personnel support: school assistants, special pedagogues, psychologists, social pedagogues, nannies for nurseries and career advisors
- Further training of teachers
- Help to pupils at risk of school failure
- Exchange of experience among teachers, tandem training
- Project-based teaching
- Interest clubs

What is the amount of financial support?

- Allocation of the call: CZK 6 billion
 - Less developed regions: CZK 5 420 000 000
 - More developed regions: CZK 580 000 000
- Minimum amount of expenditure: CZK 100 000
- · Maximum amount of expenditure:
 - for nursery and primary schools: CZK 300 000 per entity + (the number of children/ pupils x CZK 2 500);
 - for basic arts schools and non-formal education establishments: CZK 100 000 per entity + (the number of pupils/ participants x CZK 1 800)
- at the same time it must not exceed CZK 5 mil. per applicant
- The beneficiary's co-financing rate: 0%
