



Improving the quality of non-formal education (Call No 02_18_071)

What is the aim of this call?

The aim of the call is to support the development of people who are dedicated to working with youth through non-formal education. The call will allow teachers and non-formal education staff to broaden their knowledge and increase competences in new methods and forms of work. This means mainly personal and social development, the acquisition of competences in polytechnic or project-based education, exploration activities, practical use of ICT, and last but not least in the area of literacy and numeracy.

Who can apply for a grant?

Eligible applicants must belong to one of the following categories and also must meet all the conditions set out in chapter 5.2.1 of the Rules for Applicants and Beneficiaries – specific part.

- **Legal persons whose main objective is not to generate profit:**

- Associations
- Institutions
- Publicly beneficial organizations
- Registered churches (or religious societies established by them)
- Associations of legal entities

At the same time, these legal entities must operate in non-formal education of children and youth, or must associate organizations working with children and young people or be listed in the database of Local Action Groups or serve as umbrella organizations for organizations of children and youth in the NUTS 3 territory.

- **Branch associations of the National Network of Local Action Groups Czech Republic**

Each applicant is entitled to submit a maximum of one grant application.

What is the amount of financial support?

- Allocation of the call: CZK 200 000 000
- Minimum amount of expenditure: CZK 1 000 000
- Maximum amount of expenditure: CZK 20 000 000

What activities are eligible?

- **Mandatory activity:**
 - Project management
- **Mandatory-to-select activities** (in two variants, see Sec. 5.2.4 of the Rules for Applicants and Beneficiaries - specific part)
 - Training of non-formal education staff
 - Sharing experience among non-formal education staff through mutual visits
 - Tandem non-formal education
 - Introducing new methods in non-formal education
 - Project Day in the clubhouse
- **Mandatory-to-select activities** (in one variant)
 - Project Day outside the clubhouse
 - A club in non-formal education

The above activities are detailed in the call text - Sec. 5.1.1

What target groups can be supported?

- Children and students who attend non-formal education (children from 3 years, primary and secondary school pupils)
- Staff and volunteers of organizations operating in the field of education and non-formal education
- Teaching staff

How and when to apply?

Grant applications are submitted through IS KP14+ (<https://mseu.mssf.cz>) in the period from 15.02.2019 until the allocation is exhausted, at the latest till 06.01.2020, 14:00.
