What is the aim of this call?

- To support systematic, monitored and reflected introduction of innovations in teaching
- To promote quality teaching and support teachers as its key prerequisite through innovative methods
- To streamline school leadership, management and climate through innovation
- To encourage pedagogical research focused on monitoring the impact of selected educational policy measures in pre-school, primary and secondary education
- To prepare background documents for addressing problematic phenomena that have not been addressed systematically by the education policy to date

Who can apply for a grant?

 Universities, research organizations (public higher education institutions, public research organizations), state and local authorities, including their associations, organizations subordinated to them or organizations funded by them, other entities involved in the implementation of educational activities

What is the amount of financial support?

- Allocation of the call: CZK 250 000 000
- Minimum amount of expenditure: CZK 3 000 000
- · Maximum amount of expenditure:
 - for activity A: CZK 25 000 000
 - for activity B: CZK 15 000 000

How and when to apply?

Grant applications are submitted through IS KP14+ (https://mseu.mssf.cz) in the period from 27.03.2019 till 30.08.2019, 14:00.

What activities are supported and what is their allocation?

All projects must include the mandatory activity Project Management and exactly one mandatory-to-select activity marked with an A or a B. Under mandatory-to-select activity A, the applicant chooses one or two sub-activities, under activity B only one sub-activity, see below:

Mandatory activity

· Project management

Mandatory-to-select activities (the applicant must choose one of two options):

- Activity A Innovative activities in preschool, primary and secondary education (Under this activity, the applicant further chooses one or both sub-activities)
 - Sub-activity A1: Innovation of the School Education Programme
 - Sub-activity A2: Pilot verification of partial innovative activities
- Activity B Pedagogical Research (Under this activity, the applicant is entitled to choose only one sub-activity)
 - Sub-activity B1: The relationship between nursery school attendance and results, attitudes and behaviour of pupils in lower primary school
 - Sub-activity B2: Differences among schools in the results and attitudes of pupils and their linkage to the conditions of teaching and learning
 - Sub-activity B3: The causes of school failure among lower primary school pupils
 - Sub-activity B4: The life path of students failing their secondary schoolleaving exam
 - Sub-activity B5: Reasons why graduates of faculties of education do not start as a teacher/ an educator
 - Sub-activity B6: Effective forms of communication of MEYS and its directly managed organizations with education authorities and schools
 - Sub-activity B7: Identifying public opinion and its development in the field of education and education policies
