Support for children and pupils with special educational needs (Call No. 02_19_077)



What is the aim of this call?

The call supports activities leading to the increase of the competencies of teachers in the implementation of transit programmes preparing young people for independent living. The goal of the programmes is to gain working experience and increase the chances of getting a job after leaving school. When working with children with behaviour problems the teachers will also receive support through specific trainings and methodological support. The call also strives to prevent and shorten the child's stay in the system of institutional and protective education.

Who can apply for a grant?

Eligible applicants must belong to one of the following categories and also must meet all the conditions set out in chapter 5.2.1 of the Rules for Applicants and Beneficiaries – specific part.

- Legal entities operating as schools and education establishments
- Higher educational institutions
- Private-law entities whose main purpose is not to make profit and which are performing public beneficial activity:
- association, except for subsidiary association
- institute
- public benefit company
- foundation or funds
- registered church or religious community or legal entities founded by them
- State organizational units
- Contributory organizations founded by the Ministry of Health or MEYS
- Territorial self-governing units and their contributory organizations
- Interest groups of legal persons or associations micro-regions

How and when to apply?

Grant applications are submitted through IS KP14+ (https://mseu.mssf.cz) in the period from 30. 08. 2019 till 27. 11. 2019, 14:00.

What activities are eligible?

• Obligatory activity:

Project management

Obligatory-optional activity:

- Support for pedagogical staff in the implementation of transit programs and comprehensive programs preparing for independent living
- Strengthening the competencies of pedagogical staff of schools and education establishments in the field of mental health support for children and pupils
- Transformation of the current model of services of education establishments for institutional and protective education and preventive educational care into the services of prevention and early intervention

Optional activity:

 Elaboration of documents containing specific proposals for the modification of relevant passages of the Framework Educational Programs regarding the field of education "one-year and two-year practical school"

What is the amount of financial support?

- Allocation for the call: CZK 500 000 000
- Minimum amount of total eligible expenditure for activities No. 1 and 2, eventually 5: CZK 3 000 000
- Minimum amount of total eligible expenditure for activities No. 1 a 3: CZK 5 000 000
- Minimum amount of total eligible expenditure for activities No. 1 a 4: CZK 20 000 000
- Maximum amount of total eligible expenditure for all activities: CZK 70 000 000

What target groups can be supported?

- Clients of educational care centres and education establishments for institutional and protective education and preventive educational care
- Persons involved in the upbringing of the child
- Pedagogical staff of schools and education establishments
